Bob F. also noted that a refund of \$84 (\$32-District and \$52- International) was given to Stacy K. because she was a former student member. KI had only charged us \$25 for her membership.

#### Service Fund Report

Bob F. highlighted the Service Fund Report and reported that Christmas Cash for Kids (\$200 disbursed) was a new line added under expenditures. The Strategic Funding Partners money of \$2,000 was transferred to the CFoFC. Our contributions were also made to the Kiwanis Children's Foundation (\$192), the Capital District Foundation (\$96) and the Governor's Gift (\$25).

Motion by Art A., seconded by Richard R. to accept the Administrative Fund & Service Fund Report for December 2020. Motion carried

#### COMMUNITY FONDATION REPORT

Colette B. confirmed that the Foundation has distributed grants to the organizations on the approved list that we sent them.

Bob F. asked Colette B. if she had seen the email re: Builder's Club payment. Colette shared that she would be researching the Builder's Club payment.

Colette reported that the Builder's Club has not been active due to COVID, but plans to start up again in February.

Follow up to information requested at our last Board meeting regarding the payment of administrative fees to the Foundation. Colette reported that monies payed for administrative fees to the Foundation were based on the fiscal year 7/2019 ending 6/2020 with the amount being \$3,773.

Collette is seeking representatives from the organizations we support to speak at our meetings to share how they use the grant money. The President reminded those who are seeking to obtain speakers to please check with Bob K., Allen B. and send a copy to President Vona.
