Middle School Most-Improved Student Award Program Update By Colette Baker

Due to the COVID Pandemic, our club recognized the most improved middle school students via email correspondence with the school administrators and recognition packets were mailed to the students who were nominated by their school. This year would have been

the 31st annual Middle School Appreciation Banquet. 15 Frederick County Middle and Charter Schools as well as the MD School for the Deaf participated in the recognition program. Each school used its own criteria in the selection of the Most Improved Student. The selected students received by mail a packet which contained a framed recognition certificate, a \$25 Downtown Frederick Gift Card and a letter explaining why their school administrators selected them.

A compilation of statements and explanations submitted by the school administrators included:

They said you have shown tremendous growth academically, socially, emotionally and physically. You were amazing in your commitment to attending all the virtual classes during the Pandemic and were always willing to participate in classroom instruction as well. You really enjoy learning history and government and did not fall below an A in Social Studies all year.

Your teachers said you always bring a positive attitude for learning and are ready to learn. Your dedication paid off and you overcame every obstacle that virtual and hybrid learning threw your way and that you truly shined in the midst of this Pandemic.

They stated that you have made incredible progress over the past three years and are completely independent in your day - to - day activities. You have learned to become completely independent of supports and have learned healthy coping skills. You always listened to staff and have worked well with adults to overcome obstacles.

The staff are very proud of you and want to celebrate you earning Honor Roll every term in 8th grade! They are confident you are going to do great things in high school and they wish you the best of luck in the future!

They said during 6th grade you were dealing with many issues – socially, academically and emotionally. Over time, your school built you a strong staff support network and you always knew someone was "in your corner."

This year you are caring and helpful and you show true empathy for your peers around you. You have grown academically and your confidence in your abilities resulted in high grades this school year. The staff are very proud of all your hard work and personal growth while attending Urbana Middle School.

They stated that you are a model student. You highly value your education, set a great example for your peers and you help elevate the learning and level of engagement in your classes. Your hard work and perseverance in this difficult year have been admirable and

inspiring. You have become reflective and intentional about making smart choices to shape yourself into the best person you can be. The staff feel your kindness and love of learning lift them all up!

They said you learned to communicate effectively and sought out adult assistance when needed. You were resilient and able to adapt. You used your ability to communicate and problem solve to assist in advocating for others.

Your positive energy and words of encouragement in the classroom is appreciated by those around you. You have learned to manage your responsibilities on the family farm while working hard to maintain your grades in school. The teachers are very proud of your growth and resiliency both inside and outside the classroom.

They said you have made significant academic progress since joining the MD School for the Deaf family in 6th grade. You have increased your mathematical and reading levels by four grades. You made amazing progress with the number of behavior referrals (none this school year). You have risen to being on top of all your assignments and followed up with your teachers to ensure everything was completed in a timely manner.

All the middle school teachers recognize how much hard work has paid off for you. They are very proud of you and feel you are a role model for others to follow.

They said you really stepped up this school year and have taken responsibility for your grades. Prior to this year, you needed to be reminded to complete your work. This year you advocated for yourself by staying organized and keeping track of assignments. As a result, your grades have improved as well as your level of responsibility in academic integrity.

They stated that you worked hard to identify your tremendous talents and focused on your accomplishments. You listened to the caring adults around you and decided to access the curriculum to the best of your ability. During 8th grade, you strengthened your dedication to your studies and you understand how working hard in school will benefit you for years to come. The staff are confident you will continue to reach higher and they are very proud of you.

Christmas Giftwrap Update

Efforts continue to gather needed information for the Board to make an informed decision regarding the 2021 FSK Mall Charity Giftwrap for Kids fundraiser. One outstanding question I have posed to FSK Mall and am awaiting a reply is, "We make use of volunteer high schoolers for the gift wrap. If they have not been fully vaccinated, must they wear a mask when in the FSK Mall? Do you have any specific masking requirements in general for all shoppers, whether or not vaccinated?"

The second clarification regarding KI has been answered.

QUESTION:

I just read: <u>Guidelines help clubs meet safely</u> (<u>kiwanis.org</u>). From this, it would appear that our club must:

- 1.Require all volunteers, e.g., Key Club members, to either be fully vaccinated or, if not, to wear a mask and social distance. Is this correct?
- 2.Require all volunteers to sign the waiver <u>covid-travel-liability-and-assumption-of-risk</u> (kiwanis.org). Is this correct?

REPLY from April Gassler, Risk Manager for the Capital District of Kiwanis:

The guidelines from Kiwanis International are just that,

guidelines. They are suggestions from KI for how clubs can act to minimize their exposure to potential liability for actual or alleged COVID-19 exposures at any of their events in light of the fact that the Kiwanis International insurance program does not provide coverage for claims that individuals were exposed to COVID-19 at a Kiwanis Club event.

With respect to certificates of insurance, if you need to issue one as proof for someone else that the Kiwanis Club is insured in connection with your club's event, you can fill in the blanks on the standard Certificate of Insurance form from the KI website. Then simply give a copy to the party that requested the Certificate and email a copy to Hylant for their records. However, if the other party is requesting that they be added as an "additional insured" on the Kiwanis Certificate of Insurance, then you <u>must</u> request that type of Certificate of Insurance from Hylant.

The packet found at this link: https://www.kiwanis.org/docs/default-source/training/training/risk-management/20-21 us certificate packet.pdf includes instructions on how to fill in the blanks for your own standard Certificate of Insurance. It also includes a form to submit to Hylant if you need to request a Certificate with the "additional insured" wording in favor of a party outside of Kiwanis. Those requests take 24-48 hours to process so please be sure to leave ample time before your event to obtain them. If you need assistance preparing a Certificate of Insurance or submitting a request to Hylant for an "additional insured" COI, please let me know and I would be happy to assist you.

Finally, you should also request a certificate of insurance from your host facility in connection with the event, as well as any vendors assisting the Kiwanis Club with the event, if applicable. Page 23 of the Club Insurance Guide includes a sample form that you can submit to your event host and any additional vendors to request a certificate of insurance from them.
