CALL TO ORDER

President, Sue Vona, called the meeting to order at 11:42 p.m.

SECRETARY’S REPORT

Lauri C. asked the Board if they had chance to read the minutes as printed in the K-notes. Colette noted that that a comma instead of a period should be inserted under the Community Foundation Update: Decreases to equal \$11,021.15. TREASURER’S REPORT

Administrative Fund Report for October 2021


