Salvation Army Bell Ringing Update – No report

Wreaths Across America Update on monies – Richard C. reported that WAA sent a check in the amount of \$161.67 and will be processing another check for December which should be coming to us soon. It is anticipated that we should receive approximately \$300.

100th Anniversary Plan Update – Roz met with the person in charge of large events at the Red Horse and wanted a few other members to visit to see if Red Horse would work for our celebration. Sue, Bob, Richard and Lauri went to dinner at the Red Horse and reported that a nice dinner was had by all, viewed the banquet areas down stairs and were given several different food options. It was noted that this is a very special evening and that we should consider the atmosphere of the occasion. The recommendation of the Board is the Red Horse for our special event and that a sit-down meal would be nice with a choice of 3 meal options.

A committee will need to be set up in the near future to start the planning process.

Everyone agreed and said that Aktion is a great project and would like to know the specifics that go into the club’s success.

TJ Youth Athletic Association – The Board of Directors had a great amount of discussion on the request of funds from Ellen Rollman, for TJYAA. Out of the discussion it was shared that some research will be done (contact Dr. Markoe for his input) with the possibility of a representative from the TJYAA coming to giving us a presentation.
